**Tricard Pecan Kicker™** is designed to be used in a spray program of multiple applications to provides key plant food nutrients at or near the time they are needed most for enhanced yield and/or quality.

### DIRECTIONS FOR USE

This product may be applied by ground or aerial application. Use sufficient water for thorough and uniform coverage of foliage or soil. Foliar application is recommended when fast correction is desired. For best results use a non-ionic surfactant.

**Mixing Instructions:** Always check compatibility before mixing. Use only the following sequence: 1. Water; 2.This Product, 3. Pesticides.

### RECOMMENDED RATES
