GENERAL INFORMATION

COBLEND ES is an effective compatibility agent for pesticide mixtures and pesticides to be mixed with liquid fertilizers. When used at the recommended label rate, **COBLEND ES** improves the stability of these mixtures and the uniformity of their application. **COBLEND ES** is most effective when added before incompatibilities occur. **COBLEND ES** may be useful to reverse incompatibilities, but generally will require higher rates.

FIRST AID
