## GENERAL INFORMATION

Tricard EMZ DUO is designed to be used in a spray program of multiple applications to provide key plant food nutrients at or near the time they are needed most for enhanced yield and/or quality.

## DIRECTIONS FOR USE

This product may be applied by ground or aerial application. Use sufficient water for thorough and uniform coverage of foliage or soil. Foliar application is recommended when fast correction is desired. For best results use a non-ionic surfactant.

**Mixing Instructions:** Always check compatibility before mixing. Use only the following sequence: 1. Water, 2. This Product, 3. Pesticides.

## RECOMMENDED RATES

### Suggested use rate 1-3 quarts per acre with Foliar Applications

However, rates and timing of applications are dependent on local conditions and should always be made as a result of soils and/or plant tissue analysis. Local climatic conditions, infestations and other factors affect the performance of any pesticide or nutritional spray. ## WHAT TO DO IN CASE OF CONTACT
