Mixers, loaders, applicators and other handlers must wear the following:

STORAGE: Store in a safe place away from pets and keep out of the reach of children. Store away from excessive heat. FourMnXL will freeze. Always store FourMnXL above 40 degrees F (Do not Freeze). Freezing may cause product separation.

CONTAINER HANDLING:

Containers with capacities less than 5 gallons: Nonrefillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure 2 more times. Offer for recycling if available. If recycling is not available, puncture and dispose of in a sanitary landfill, or by incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.

GENERAL INFORMATION

FourMnXL is designed for foliar applications to growing crops, alone or with other fertilizers and pesticides. FourMnXL may be applied by foliar application, through irrigation systems, or directly to soil. It is compatible with most water dispersed pesticides and may be applied via high volume, low volume or aircraft sprayers. It is recommended for all field, row, vegetable, fruit, tree and vine crops.

COMPATIBILITY

FourMnXL is compatible with most pesticides and fertilizers. A jar test to check the compatibilities of other products should be performed prior to mixing.

DIRECTIONS FOR USE

CAUTION: Avoid co-application with phosphate-containing fertilizer solutions. Contents may need agitation before use. Always add this product to spray tank before adding herbicides and pesticides. Actively growing plants with young leaves absorb micronutrients most effectively. Avoid foliar applications of this product when plants are under moisture stress. Application immediately after irrigation or rainfall will give best foliar uptake of micronutrients.

RATES: ALL CROPS

Micronutrient Maintenance.....1-3 pts/acre
Light Deficiency 2-4 pts/acre
Severe Deficiency..... 1-2 qts/acre

Lower rates should be used on field, row and vegetable crops. Higher rates should be used on fruit, tree, and vine crops. When rates of over 2 qts. are called for, split or multiple applications of 2 qts. or less each are preferred. Applications should be separated by a minimum of 10-14 days.

Air Applications: Normal aerial application is 1-2 pints of this product per 5 gallons of water per acre per application.

Drip Irrigation: The required amount of this product should be applied over the growing season of the crop by multiple applications 1 to 2 weeks apart.
