GENERAL INFORMATION

Tricard **PECAN KICKER**[™] is designed to be used in a spray program of multiple applications to provide key plant food nutrients. **PECAN KICKER** has been formulated for the optimum ratio of Nitrogen and Potash to help increase Fall leaf retention and aid in decreasing the chances of Winter injury. The Potassium in **PECAN KICKER** will also help to decrease leaf scorch and increase kernal oil content.

DIRECTIONS FOR USE

PECAN KICKER may be applied by ground or aerial application. Use sufficient water for thorough and uniform coverage of foliage or soil. Foliar application is recommended when fast correction is desired. For best results use a non-ionic surfactant.

Mixing Instructions: Always check compatibility before mixing. Use only the following sequence: 1. Water, 2. **PECAN KICKER**, 3. Pesticides.

RECOMMENDED RATES

Rates and timing of applications are dependent on local conditions and should always be made as a result of soil and/or plant tissue analysis.
