This product may be used as a replacement for non-ionic surfactants and crop oil (petroleum oils) in most post-emergence herbicide spray mixes. Methylated seed oils tests by universities and research indicate methylated seed oil improves the performance consistency of post-emergence herbicides such as Accent®, Accent Gold®, Assent®, Beyond™, Chopper®, Classic®, Drive®, Equip™, Journey™, Option®, Osprey®, Plateau®, Poast®, Poast Plus®, Pursuit®, Raptor®, Revolver™, Ultra Blazer® and other herbicides.

Use this product at 1 pint to 5 quarts per acre with post-emergent herbicides. Higher rates may be necessary for special applications.
