TRI-CARD CONCENTRATED DEFOAMER is very aggressive in agricultural pesticide tank mixes, especially ***ROUNDUP®** Pesticide Formulations, offering antifoaming qualities when used in a premix or defoaming characteristics on already existing foam. All emulsifiers used in this formulation are non-ionic, offering superior uniformity and compatibility.

USE RATES

Use **TRI-CARD CONCENTRATED DEFOAMER** at 1 to 2 ounces per 100 gallons of solution. It may be necessary to adjust the amount used according to individual conditions.

NOTE: It is always best to add to tank mixture before foam has already formed.

STORAGE AND DISPOSAL

Keep from freezing. Store in a cool dry place. Do not reuse empty container. Dispose of container in a safe manner in accordance with federal, state and local regulations. Do not contaminate water by cleaning of equipment or disposal of wastes.

FIRST AID

If Ingested: Get medical attention immediately. Do not induce vomiting, except by physician's order.
