GENERAL INFORMATION

TOPSIDE LIQUID BORON is a proprietary formulation combining nitrogen and boron with a special surfactant that enhances penetration and translocation.

TOPSIDE LIQUID BORON is recommended for use on row crops, vegetables and fruit and nut trees. Applied in a program of multiple applications throughout the growing season assures a continuous supply of Boron at or near the time it is needed most to enhance yield and quality.

TOPSIDE LIQUID BORON provides boron in the only form absorbed by crops. Boron is a key nutrient in photosynthesis, cell wall structure, plant hormone regulation, translocation of sugar and starches, fruiting and flowering and in nitrogen utilization. A deficiency can affect quality as well as yield.

DIRECTIONS FOR USE

TOPSIDE LIQUID BORON is compatible with most pesticides and will disperse in water with minimal agitation. A jar test is always recommended prior to mixing and application. Follow the mixing sequence: 1. Water; 2. **TOPSIDE LIQUID BORON**; 3. Pesticide.

Minimum water recommended: *Ground application:* 20 GPA; *Aerial application:* 5 GPA

RECOMMENDED RATES

SOIL APPLICATION: Apply 1 - 4 quarts per acre as a side dress or broadcast.

AERIAL APPLICATION: Apply 1 - 4 quarts per acre per application. At least 2 applications per growing season are recommended. Additional application may be necessary under weather conditions of either excessive rain or drought.

FOLIAR APPLICATION: Apply 1 - 4 pints per acre per with sufficient water for thorough coverage. Multiple applications may be necessary.

TOPSIDE LIQUID BORON may be corrosive to aluminum, mild steel and brass. Store in stainless steel containers. Use only stainless steel, P.V.C. or polypropylene fittings.

STORAGE: Store in cool place in original container in a locked storage area inaccessible to children, pets or wildlife.

CONTAINER DISPOSAL: Do not reuse empty containers. Triple rinse (or equivalent), then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state or local authorities.

CAUTION: Harmful if swallowed. Avoid contact with eyes, skin and clothing. Avoid breathing spray mist.
